The change of the number of votes ensued as a result of the purchase transaction at GPW, conducted on 2022-03-07.

Before the purchase transaction of the Company shares, the PGAB accounts held 5,061,938 Company shares, which constituted 22.16% of the Company equity capital and entitled to execute 5,061,938 votes at the Company general meeting, and attributed 19.97% stake in the total number of votes in the Company.

As a result of the purchase transaction concluded on 2022-03-07, the PGAB accounts held on 2022-03-07 5,161,999 Company shares, which constituted 22.59% of the Company equity capital and entitled PGAB to execute 5,161,999 votes at the Company general meeting, and attributed 20.36% stake in the total number of votes in the Company.

PGAB do not exclude the possibility of purchasing or selling shares in the course of the oncoming 12 months depending on the market circumstances.

Moreover, PGAB informs that: (i) there exist no entities dependent on PGAB, which possess the Company shares; (ii) nor there exist people, mentioned in Art. 87 para 1 item 3 letter c) of the Act; neither (iii) does it possess financial instruments mentioned in Art. 69 para 4 item 7 and 8 of the Act concerning the Company shares.
