Acting under Art. 362 § 1 (8), Art. 362 § 2 of the Code of Commercial Companies and § 18sec. 2 of the Company's Statute with regards to art. 9 and art. 53 of the Council Regulation (EC) No. 2157/2001 of  $8^{th}$  October 2001 on the Statute for European Company (SE), it is resolved as follows:

General Meeting hereby amends § 2 (2) of Resolution No. 7 of the Annual General Meeting of 19<sup>th</sup> May 2015 on the authorization of Company's Management Board to acquire Company's own shares and on the reserve capital for the acquisition of own shares pursuant to art. 362 § 1 (8) of the Code of Commercial Companies, repealing it and giving it new wording as follows:

"2) the purchase price per Own Share shall not be less than 24 (twenty four) PLN nor more than 500 (in words: five hundred) PLN;"
