Nr 184, poz. 1539 – Journal of Laws No 184, item 1539, with amendments, henceforth "the Act") informs that the stake of PGAB in the total number of votes at KRAKCHEMIA S.A. with a seat in Kraków general meeting, registered in the Company Register of the Domestic Court Register under the KRS entry 0000217348 ("the Company") amounted to 10,58%.

The change of the number of votes ensued as a result of the purchase transaction at GPW (off-market deal), conducted on 14.09.2018.

Before the purchase transaction of the Company shares, the PGAB accounts held 502 242 Company shares, which constituted 5,58 % of the Company equity capital and entitled to execute 502 242 votes at the Company general meeting, and attributed 5,58 % stake in the total number of votes in the Company.

As a result of the purchase transaction concluded on 14.09.2018, the PGAB accounts held on 14.09.2018 952 242 Company shares, which constituted 10,58 % of the Company equity capital and entitled PGAB to execute 952 242 votes at the Company general meeting, and attributed 10,58% stake in the total number of votes in the Company.

PGAB do not exclude the possibility of purchasing or selling shares in the course of the oncoming 12 months depending on the market circumstances.

Moreover, PGAB informs that: (i) there exist no entities dependent on PGAB, which possess the Company shares; (ii) nor there exist people, mentioned in Art. 87 para 1 item 3 letter c) of the Act; neither (iii) does it possess financial instruments mentioned in Art. 69 para 4 item 7 and 8 of the Act concerning the Company shares.
