The Notifier acting pursuant to Article 69 section 1 paragraph 1 of the Act of July 29th, 2005 on Public Offers and Conditions of Introduction of Financial Instruments to Organized Trading System and on Public Companies (Journal of Laws No. 184, Item 1539, unified text Journal of Laws from year 2022 Item 2554) (the “**Act**”) hereby notifies that BLACK FOREST SICAV-SIF societe anonyme, 18, rue de l’Eau, 1449 Luxembourg, Grand Duchy of Luxembourg, registered in Luxembourg trade and companies register under the number B203895 subsidiary of the Notifier sold 799.310 (in words: seven hundred ninety nine thousand three hundred ten) shares of Molecure S.A. with its seat in Warsaw, LEI code 2594003L11V38ZCVKZ09 (respectively the “**Shares**”, the “**Company**”), constituting 4,75% (four seventy five hundredths percent) of the Company’s share capital, authorising to 799.310 (in words: seven hundred ninety nine thousand three hundred ten) votes at the Company’s general meeting and representing 4,75% (four seventy five hundredths percent) of the total number of votes at the Company’s general meeting.

The sale of the Shares results from block transactions executed during the session on December 20th and December 21st, 2023 (the “**Transactions**”). As a result of the Transactions Notifier get directly and indirectly below 25% (twenty five percent) of the total number of votes at the Company’s general meeting.

Prior to the Transaction the Notifier held:

- 1) directly 3.367.200 (in words: three million three hundred sixty seven thousand two hundred) shares in the Company, constituting 20% (twenty percent) of the Company’s share capital, authorising to 3.367.200 (in words: three million three hundred sixty seven thousand two hundred) votes at the Company’s general meeting and representing 20% (twenty percent) of the total number of votes at the Company’s general meeting;
- 2) indirectly through BLACK FOREST SICAV-SIF societe anonyme, 18, rue de l’Eau, 1449 Luxembourg, Grand Duchy of Luxembourg, registered in Luxembourg trade and companies register under the number B203895, which held 1.632.110 (one million six hundred thirty two thousand one hundred ten) shares of the Company, constituting 9,69 % (nine and sixty nine hundredths percent) of the Company’s share capital, authorising to 1.632.110 (one million six

hundred thirty two thousand one hundred ten) votes at the Company's general meeting and constituting 9,69 % (nine and sixty nine hundredths percent) of votes at the Company's general meeting.

At present the Notifier holds:

- 1) directly 3.367.200 (in words: three million three hundred sixty seven thousand two hundred) shares in the Company, constituting 20% (twenty percent) of the Company's share capital, authorising to 3.367.200 (in words: three million three hundred sixty seven thousand two hundred) votes at the Company's general meeting and representing 20% (twenty percent) of the total number of votes at the Company's general meeting;
- 2) indirectly, through BLACK FOREST SICAV-SIF societe anonyme, 18, rue de l'Eau, 1449 Luxembourg, Grand Duchy of Luxembourg, registered in Luxembourg trade and companies register under the number B203895, subsidiary of the Notifier, holds 832.800 (in words: eight hundred thirty two thousand eight hundred) shares in the Company, constituting 4,95% (four ninety five hundredths percent) of the Company's share capital, authorising to 832.800 (in words: eight hundred thirty two thousand eight hundred) votes at the Company's general meeting and representing 4,95% (four and ninety five hundredths percent) of the total number of votes at the Company's general meeting.

The Notifier, directly and indirectly, holds 4.200.000 (four million two hundred thousand) shares of the Company, constituting 24,95% (twenty four and ninety five hundredths percent) of the Company's share capital, authorising to 4.200.000 (four million two hundred thousand) votes at the Company's general meeting and representing 24,95% (twenty four and ninety five hundredths percent) of the total number of votes at the Company's general meeting.

There are not any persons referred to in Article 87, paragraph 1, subparagraph 3, letter c of the Act.

There are not any financial instruments referred to in Article 69b, paragraph 1 of the Act.
