### **NOTIFICATION ON THE SALE OF SIGNIFICANT BLOCK OF SHARES IN A PUBLIC COMPANY**


In accordance with Article 69.1.2 in connection with Article 87.5.1 of the Act of July 29, 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organized Trading, and Public Companies, Franklin Resources, Inc., with its corporate seat in Delaware, U.S.A., being parent company of Franklin Templeton Investments (ME) Limited and Templeton Asset Management (Poland) TFI S.A. (the "subsidiaries") hereby notifies that on 5 October 2018 as a result of sales of 178,380 shares held in Synektik S.A. with its corporate seat in Warsaw, Poland, (the "Company"), the total shares held fell below 5% of the total shares in the Company.

Before the sale of shares, Franklin Resources, Inc. together with the shares held by its subsidiaries held 524,632 shares in the Company, constituting 6.15% of the share capital which represent 524,632 votes, constituting 6.15% of the total vote. The FTIF Templeton Eastern Europe Fund, managed by Franklin Templeton Investment (ME) Limited held 520,752 shares in the Company, constituting 6.11% of the share capital which represents 520,752 votes, constituting 6.11% of the total votes.

After the sale of shares, Franklin Resources, Inc. together with the shares held by subsidiaries held 346,252 shares in the Company, constituting 4.06% of the share capital which represent 346,252 votes, constituting 4.06% of the total votes.
